**Licensed Medical Home Care** is most often skilled care by a Registered Nurse, Physical, or Occupational Therapist after a change in health (i.e., surgery, accident, illness/declining health). Medicare and other insurance can often cover Licensed Medical Home Care for short periods of time. To be covered by insurance, this type of care must be prescribed by a doctor.
