

Getting Started

Expertise & Experience

The organizations in this booklet have the expertise and experience to answer your questions. They understand your challenges and the descriptions are meant to give you a short overview of what each organization does. We encourage you to contact them directly for more information.

What is Advocacy?

Advocacy is simply trying to influence others who provide services or make policies that affect our lives. By participating in advocacy, you move from a powerless bystander to a person empowered and in control of the quality of your life and/or the people you care about.

Organizations Active in Advocacy

The organizations listed serve people with disabilities and are active in personal, public, and legislative advocacy. Many teach individuals how to advocate for themselves.

Types of Advocacy

Personal Advocacy - Helping yourself or other understand their choices and/or get services. Sharing ideas at a support group, accompanying someone to an appointment or meeting with a service provider, or helping others represent their needs.

Public Advocacy - Activities that educate the general public to gain understanding. Speaking to a club, church, or other organization, writing a letter to the editor or submitting an article, or posting a blog.

Legislative Advocacy - Working to influence legislation on a local, state, or national level.

Disability Rights helps people across Wisconsin gain access to services and opportunities through information and referral, trainings, advocacy, and legal expertise. Disability Rights challenges systems and society to create positive change and improve the lives of people with disabilities.

The Ombudsman Program is a free advocacy program for anyone over 60 years of age that is living at a facility or a community agency providing long-term care. Any residents, tenants, families and friends, or staff members can access this service. Ombudsman staff are direct advocates for people needing long-term care. The program is required by law, with the Board on Aging & Long Term Care being the direct provider of these services in the state of Wisconsin.

Recognizing the importance of quality of life and quality of care, an Ombudsman works with individuals and their families/caregivers to protect and promote the rights of long-term care consumers, while also working with facilities to define and achieve the highest standards possible. Ombudsman can answer questions about the different care options available, investigate complaints against care agencies, help residents and tenants resolve problems or concerns, and protect the rights of consumers guaranteed by state and federal laws. Ombudsman can be contacted by phone or give face-to-face assistance in a facility.

It has become a leading source of information and support in Wisconsin for children and youth who have special needs, their families, and others who support them.

WI FACETS offers a variety of services including: information and referral, building a partnership between parents and those who provide services to their children, educating parents on their rights and how to use those rights to become involved in their child's education, developing leadership and self-advocacy skills, parent support and assistance with Individualized Education Plans (IEPs), and parent leadership development.

WSPEI is designed to support parents of children with disabilities in their understanding of, and participation in, the special education process. It is a service for parents, educators, and others interested in parent-educator partnerships for children with disabilities. The program is funded through the Wisconsin Department of Public Instruction (DPI).

WSPEI provides information and assistance in understanding special education services in Wisconsin. Services include advocacy for parents, help in contacting a parent liaison in your school district, and assistance with developing Individualized Education Plans (IEPs).

The ARC-Wisconsin works with other community agencies and local government to offer training on how services and programs should be designed to assist people with disabilities.
