



### What is Advocacy?

Advocacy is simply trying to influence others who provided services or make policies that affect our lives. By participating in advocacy you move from a powerless bystander to a person empowered and in control of the quality of your life and/or the people you care about.

### **Types of Advocacy**

**Personal Advocacy** - Helping yourself or others understand their choices and/or get services. Sharing ideas at a support group, accompanying someone to an appointment or meeting with a service provider (some listed in this booklet) or others to help represent their needs.

# Ombudsman Program

The Ombudsman Program is a free advocacy program for anyone over 60 years of age that is living at a facility or a community agency providing long-term care. Any residents, tenants, families and friends, or staff members can access this service. Ombudsman staff are direct advocates for people needing long-term care. The program is required by law, with the Board on Aging & Long Term Care being the direct provider of these services in the state of Wisconsin.

Recognizing the importance of quality of life and quality of care, an Ombudsman works with individuals and their families/caregivers to protect and promote the rights of long-term care consumers, while also working with facilities to define and achieve the highest standards possible. Ombudsman can answer questions about the different care options available, investigate complaints against care agencies, help residents & tenants resolve problems or concerns, and protect the rights of consumers guaranteed by state & federal laws. Ombudsman can be contacted by phone or give face-to-face assistance in a facility.
