## Description

A nursing home is a healthcare facility that provides around the clock care and services for people who need more than seven hours/week of nursing or personal care.

## Mandatory Services

1. Must provide sufficient staff (Nurses and Certified Nursing Assistants) to meet the needs of all residents.
2. Conduct comprehensive, ongoing assessments by an interdisciplinary staff to determine the needs of each resident.
3. Develop a plan of care (with the resident's input) that identifies the needs and wants of the resident, sets goals with timelines, indicates the services to be provided to meet those goals, and focuses on quality of care and life.
4. Provide social services to meet the psychological, social, and emotional needs of each resident, in accordance with the comprehensive assessment. The social worker should be the resident's advocate.
5. Provide & promote in-house & community leisure time activities to meet the interests and needs of each resident, in accordance with the comprehensive assessment.
6. Nursing services must be provided to ensure that each resident stays as independent as possible, providing assistance with daily living skills as needed, and providing skilled care, in accordance with the comprehensive assessment.
7. Manage and administer medications, according to physician's orders, unless the resident chooses to and is capable of doing this her/himself.
8. Provide three meals a day, plus snacks, including providing therapeutic diets, as ordered by the physician.
9. Provide rehabilitation services identified in the plan of care, such as: physical, occupational therapy, speech therapy, and mental health services.

## Licensing

Nursing homes are licensed by the Wisconsin Department of Health services, and the license is renewed annually. Onsite inspections occur approximately annually, and there is a requirement to investigate complaints. Resident rights are protected in the regulations.

## Dementia- Things to Consider

1. Does the program statement indicate the facility serves people with dementia?
2. Does the facility call itself dementia specialists? Does it have a special care unit or in-house program with a trained coordinator?
3. Does the facility seek guidance from the Alzheimer's Association?
4. What type of training has the staff received concerning dementia? Has all of the staff been trained?
5. Is the staff able to handle difficult or challenging behaviors? Are they trained on the most effective & humane approaches? Are physical or chemical restraints used?
6. How many staff members are there? How many residents have dementia? (What is the staff:resident ratio?)
9. Is the environment safe for a person with dementia? At what point will the facility refuse to keep the person? Is there care for the late stages of dementia?
10. Are the activities appropriately structured for individuals who have dementia or who experience "sundowning" (awake at night)?
