Payment

RCAC's accept a variety of payment options. Insurance, Medicare, and Medicaid do not pay for room and board at RCAC's. In Brown County, some adults may be eligible for Family Care as a payment option. To learn more about the program and eligibility, contact the ADRC of Brown County.

Mandatory Services

Must provide up to 28 hours/week of supportive, personal, and nursing services.

Supportive services: meals, housekeeping, laundry, arranging medical appointments, and transportation

Personal services: daily assistance with dressing, eating, bathing, grooming, toileting, transferring, ambulating, or mobility

Nursing services: health assessment & monitoring and medication administration & management

Advocacy

The Wisconsin Board on Aging & Long-Term Care Ombudsman Program provides advocacy services to residents 60 years of age and older only to those living in a certified facility and using Family Care as a payment type.

Registration/Certification

Definition: Five or more adults residing in a complex with independent apartments that have a lockable entrance and exit. Apartments must include: kitchen, living area, bedroom, and private bathroom. RCAC's are certified or registered by the Wisconsin Department of Health Services (DHS).

Registration: RCAC's that accept private pay only. These facilities will not be inspected annually, but complaints will be investigated.

Certification: RCAC's that accept public funding. These facilities will be inspected approximately every 2 years, and complaints will be investigated.

Dementia- Things to Consider

1. Person must be able to enter into a service agreement & risk contract at admission.
2. Person must be able to recognize danger, summon assistance, express needs, and make care decisions at admission.
3. Person cannot have an activated Health Care Power of Attorney (POA), nor be under guardianship, at admission.
(Exception: Person shares an apartment with a competent spouse or other person who has legal responsibility for the individual.)
4. If the person becomes incapacitated or incompetent while in the RCAC, the person may continue residence only if adequate oversight, and services are

A legal decision maker must be in place and sign the service & risk contract.
