The ADRC empowers and supports older adults, adults with disabilities, and their caregivers. You can either schedule an appointment or walk in to meet with an ADRC Specialist. Additionally, the ADRC partners with United Way's 211 resource center to help connect individuals with community resources. Housing Options

Finding a place to live after being released from prison can be difficult, especially when there are concerns about a new criminal record/background. Listed below are more resources related to finding housing, both temporary and permanent.

ATTIC offers a variety of services, including two housing programs for ex-offenders: Transitional Living Program and Community Residential Program. Referrals to the housing programs must be made through a Parole Officer (PO) or the Department of Corrections (DOC).

Accessing Long-Term Care Facilities

If an ex-offender needs to access any type of long-term care facility (including adult family homes, assisted livings, and nursing homes), it is advisable to tell the admissions director about any current supervision prior to admission. Facilities are responsible to ensure the safety and well-being of all residents. If a facility has a number of vulnerable residents, it could be determined not to admit a particular ex-offender on the basis of protecting other residents.

Brown County Housing Authority

The Brown County Housing Authority mainly offers the Housing Choice Voucher Program (Section 8), which helps low-income families, seniors, veterans, and people with disabilities pay for safe and affordable rental housing in the private market. With this program, families can choose their own apartment, house, or townhome, and the Housing Authority pays part of the rent directly to the landlord. They also provide Project-Based Vouchers, which are tied to specific rental units, and special vouchers like VASH for veterans and FUP for families and young adults leaving foster care.

All Seasons Transformation (AST), formerly Transformation House

Men only shelter provided at a reduced and affordable rate. A 49-bed transitional living facility for men who are experiencing a transition in their lives. This secure and sober facility serves men of all ages through advocacy, safety, and support.

Freedom House

Christian-based homeless shelter that provides housing for families with children. Intake is completed primarily by telephone. There are no fees. Residents must have a clean criminal record and be drug and alcohol free.

Provides 24-hour emergency shelter for women who are victims of domestic abuse and their children. There are no fees or eligibility requirements.

- **Emergency Shelter:** Housing first shelter and support for families with children, with a specialty in providing services for young parents ages 17-24 and their children of any age.
- **Housing Stability Program:** Housing search and placement, case management, and financial assistance for families with children.
- **Hope Center:** Shelter and supportive programming for unaccompanied youth ages 0-17.
- **Sustaining Hope:** Support offered to people served by House of Hope programming who return for case management, supportive connections, referrals, and resources to ensure they can remain stably housed.

New Community Shelter

Screening required to determine admission. Transitional living program helps transition from homelessness to self-sufficiency. Zero tolerance for drugs and alcohol. Must have a background clear of violent/assault charges. There are no fees.

Provides assistance and services to move people from poverty to opportunities/economic security.

Programs available:

- **Permanent Supportive Housing (PSH) Program:** Provides a permanent housing options to chronically homeless families in Brown County.
- **Youth Rapid Re-Housing Program:** Provides up to 24 months of rental assistance and training and development by case management with independent living skills for each participant.
- **Homeless Prevention Program:** Targets individuals/families that have an eviction of 14 days or less. The case manager will work with the landlord to mediate the situation, if possible and/or assist the applicant in finding another unit.
- **Tenant Based Rental Assistance (TBRA) Program:** Program providing rental assistance to individuals/families experiencing homelessness or those at imminent risk of becoming homeless **living in Brown but excluding the city of Green Bay.** Priority is given to the disabled, those who have a disabled family member, low-income who are disabled or have a disabled family member, and those who are chronically homeless or at risk of becoming chronically homeless. Preference is then given to applicants who have been diagnosed with a mental illness.

Safe Place Parking offers a designated parking lot for people experiencing homelessness who are sleeping in their cars. The lot provides a safe, secure environment for individuals to rest overnight, with staff on hand to ensure proper registration, assist with parking, and connect parkers to community resources. This program helps fill a gap in the homeless-to-housing continuum by offering a safer alternative for those without stable housing.

Housing- Sex Offenders

Brown County municipalities have different restrictions on where sex-offenders can live. This can make finding housing difficult when re-entering into society. With planning, however, a sex-offender can be successful. NOTE: Individuals with offenses that violate WI statute 948 may be required to register with the Wisconsin Sex Offender Registry.

Financial- General

ACCESS- See if You Qualify

Find out what government funded financial assistance programs you may qualify for by checking out ACCESS, an internet tool provided by the Wisconsin Department of Health Services. It asks a few basic questions about the people in your home, our finances, and your bills. Your answers are private and secure.

ACCESS will outline what programs you may be eligible for and how to apply. Their website is accessible in English or Spanish. Go to www.access.wisconsin.gov and click on "Am I Eligible?" If you do not have internet access, you can use computers free of charge at ADRC, Brown County Public Libraries, Micah Center, and Brown County Job Center.

The Wisconsin Home Energy Assistance Program (WHEAP) assists eligible households with their heating and electric bills. WHEAP provides assistance for heating costs, electric costs, and energy crisis situations. **WHEAP assistance is a one-time payment during the heating season (October 1-May 15).** The funding pays a portion of energy costs, and the payment is not intended to cover the entire annual energy costs of a residence. The amount of energy assistance payment varies depending on a variety of factors, including the household's size, income, and energy costs.

Discount Cellular Phone

The Lifeline Program offers discounted or free phone service (landline or cell) to eligible low-income customers through participating providers. It is available for residential customers, but each household can only receive the discount on one phone line, either wireless or landline, not both. To qualify for Lifeline service, you must be eligible for the Homestead Tax Credit or be a recipient of one of these programs: Wisconsin Works, Medical Assistance, BadgerCare, Supplemental Security Income, Food Stamps, Low-Income Home Energy Assistance (LIHEAP), Federal Public Housing Assistance, TANF, or have an income below 135% the federal poverty level.

Call your current cell/phone carrier and say that you want to apply for Lifeline benefits.

Legal Rights

Concerned about employment laws? Discuss rights and options with an attorney. There are some cases where a person can legally answer "no" on a question about a past offense. In some states, for example, ex-offenders do not have to report arrests that did not end in a conviction, are not currently pending, or cases in pre-trial stages where the conduct may not be considered a criminal offense (i.e. pre-trial diversion or delayed entry of judgment).

Beware of "notarios"! These people generally charge high fees and lack accreditation, continuing training and education in immigration law. Often "notarios" file incorrect and unnecessary paperwork. The advice and information they give about immigration laws and procedures is often false and misleading. This has led to serious consequences for many who unknowingly trusted a "notario" with their application.

Sex Offenders- Reporting Requirements

Those convicted of sexual-related offenses have requirements and regulations over & above those convicted of nonsexual-related offenses. To get a better understanding of the resources available in Brown County for sex-offenders, including municipality ordinances/housing requirements and the Sex Offender Housing Board Process, take a look at the section below.

Reporting Requirements

Registered sex offenders have certain reporting requirements in the United States. Each state has a Sex-Offender Registry.

Use this section to better understand where and when reporting needs to occur in Brown County.

You are required to tell the Sex Offender Registry (WI SOR) when you:

▷ Change: Residence

▷ Start/Stop:

- Working, including self-employed
 - Volunteering
 - Going to school, including on-line
1. List all email addresses, internet identifiers - including all websites and apps you create and/or use. Include social networking sites.
 2. Provide all your login, user, profile & screen names for each website/app. (Ex. Facebook, Twitter, Netflix, etc).
 3. NOTE: If you are confined to a county jail or out-of-state prison, including federal prison, for more than 10 days, you must notify WI SOR of your confinement location as well as when you are transferred or released.

If on parole, changes must be reported before they occur or within 24 hours if change was unexpected. (Note: Permission must be granted by Agent before changes can be made). If not currently on parole but under supervision changes/updates must be reported within 10 days.

Sex Offenders- Reporting Requirements Continued

*If moving outside the state of Wisconsin, a person must report to the WI Registry, as well as the new state's registry.

One-on-One Mentoring Support

Sometimes, having extra one-on-one assistance can be very beneficial when transitioning back into the community. Personalized support can offer guidance, answer questions, and help address specific challenges, making the process of reintegration smoother and more manageable.

Windows to Work Program

Windows to Work is a pre- and post-release program designed to address criminogenic needs that can lead to recidivism including employment, anti-social cognition/personality, anti-social companions, education and life experiences. The Windows to Work Program has been providing service since 1998 to over 1200 individuals.

Currently three institutions are served:

- Taycheedah Correctional Institution (serving women)
- Kettle Moraine
- Green Bay Correctional Institutions (serving males)

Eligibility Requirements:

Individuals must be currently incarcerated, releasing in no less than 90 days no more than 12 months and remaining on community supervision for at least one year. Service referrals are from the institution, DOC central office, and self-referral.

Services:

Post release services include accessing food shelter, clothing, transportation, work supplies, employment assistance coupled with mentoring and counseling with the coach. Participants receive five program components prior to release: Cognitive Intervention, General Work Skills and Expectations, Financial Literacy, Community Resources, and Job Seeking Skills.

The clients learn how to see the big picture, to understand what they can and can't control, and to become accountable and responsible for their actions based upon a philosophy created by Harry Sydney titled "The IRS Code" Integrity, Respect, and Standards. In short, the mentor provides the individual with tools, skills, and knowledge, and direction to change their life and become valuable members of the community.

Eligibility Requirements:

The mission is to provide mentoring service with "Straight Talk-Sound Direction" to individuals that lack necessary life coping skills. Participants range from boys and men age 8-65 identified by the schools, courts, and parents struggling with defining and achieving realistic goals.
